They are meant to recover and help you understand the research work done by Dr Raymond Royal Rife (May 16, 1888 – August 5, 1971) in the correct way, since a lot of fragmentary papers have appeared together with many wrong interpretations, and to date no exhaustive report exists.

This book is also meant as an answer to the book "The Cancer Cure That Worked: 50 Years of Suppression" by Barry Lynes (ISBN 0919951309), which tries to explain Rife's work but fails to replicate the research work in its entirety, leaving many unanswered questions. His efforts contributed to the revival of Rife technology, but also reinforced its cataloging as quackery and pseudo-science, as his claims could not be verified and appeared largely exaggerated and unscientific<sup>1</sup>. As the title of Lyne's book implies, Rife was experimenting with a cure against cancer that worked, in the '30s, but its details were lost, so that all the so called contemporary Rife machines do not work as expected, because they are not built on the same principles. Because of this, we titled our book "The Cancer Cure That Works", since we disclose many things about the real Rife research that were hidden or lost and make replication viable. With the information contained in this book, Rife research can now work giving out the same results that he saw with his own eyes. We are not implying that Rife technology is effective against cancer: We are only releasing the overlooked lost details of a historical research that has a history of successes wrapped in mystery and

### Preface

Dedicated to my son, Elia Manu Del Tin: "Elia, never stop to that which the others want you to believe, search to the end and you will find the ultimate truth".

I started to write this book with the goal to make a standard reference text for Rife researchers, where it is possible to find every detail of Rife work, whether it was already made public or not. As time was passing and the documentation becoming too big for a single book, I decided to make this work just a big introduction to Rife technology, reserving the deepening of specific aspects (such as the calibration of the Beam Ray, the Microscope, the building of the MOR lists, etc.) to future treatises.

Here, you will find the complete explanation of the "thing", as Rife used to call it, referring to the Beam Ray instrument that was used to devitalize living microorganisms.

It will be my concern to report exactly that which was in Rife's mind, how he performed his experiments, why he chose certain technologies, and what he was working on. I will do this bringing scientific evidence of each single phenomenon and also taking into account modern post-Rife developments that are not known to the general public.

What this book is not about is giving a cancer cure out of the box, or ready schematics that anyone can build to have a real Rife machine. As the reader will learn, there are much more parameters to take into account to get the "thing" working than it is usually believed. However, I will give the general mathematical formulas and part details that will enable a skilled researcher to build working prototypes as they are intended to be.

This book is also not about Rife's history, of the history of his devices, for there is already a lot of information around. I assume that the reader is already familiar with the subject. Therefore, this book will be a technical reference for researchers, rather than a primer on Rife work. I will start from where the existing general knowledge of the matter stops.

All these books will give you a general introduction. You will find many bits of information, sometimes contrasting. Some authors had indeed some results. However, as you will learn, none of them has the complete truth as Rife perceived it. The closest reconstruction was made by Jeff Garff in his "The Rife Machine Report: A History of Rife's Instruments And Frequencies", which I will take as the starting point in many explanations. So, I advise you read it thoroughly. There are some conclusions that I deem wrong, but we will see this in detail. The good is that, after so many people working and trying to revive Rife technology, the community is so close to it that we just need to complete the puzzle. I would say now that, had I not even met the people who put me on the right track, just by reading carefully all the public documents that became available one could reach the truth: It has always been there straight in front of our eyes. Unfortunately, everybody wants to give his own interpretation, which is filtered through his own culture and knowledge. And this led to certain historical errors that had an impact on the whole community. Fortunately, it came the time to straighten the things out.

The book is divided into five parts. Part 1 narrates briefly the story of somebody who preserved and further developed Rife technology, which is not known by the mainstream.

Part 2 explains some fundamental concepts in order to understand better Rife's work. Part 3 analyses the existing documentation, clarifying the most obscure points and explaining throughout the principles of the Rife Ray.

Part 4 leaves the historical debate to focus exclusively on building new working models, both with the original technology that Rife used and with modern components. Part 5 illustrates common lab protocols.

Finally, as the research developed, many good working models emerged, which are not necessarily Rife's, but which are still based on his principles. Therefore, we found useful to expand on them also, even if this might seem to add some confusion. At the end, Rife himself considered his study as very preliminary and recommended everybody to do his own work, and this is exactly what we have been doing.

It is the author's wish that, thorough this publication, clarity is made once an forever on Rife's research, contributing to remove his name from pseudo-science and quackery and restitute him to the place he belongs to: Science.
